



The Special General Council Meeting of Tennis Ball Cricket Federation of India held at Hotel Vivek, in front of State Bank of India, Bank Road, Gorakhpur (U.P.) on 16th February 2020 at 11:30 A.M. For Election of office bearers of Tennis Ball Cricket Federation of India (TBCFI) For 2020 to 2024.

At the outset of the meeting Shri Amjad Usmani (Uttarakhand) proposed the name of Dr. Gangadhariah, (Karnataka) to preside the meeting and he was supported by Shri R.D. Prasad (A.P.) and also supported by all the members present in the meeting.

He also told everyone to cooperate for running the Federation smoothly, and also congratulated all the newly Elected office bearers of TBCFI for 2020-2024 and extended heartiest congratulation to Dr. Abhinav Nath Tiwari for been elected unopposed as President of TBCFI continuously for 2nd term.

With the permission of the chair, Shri Amjad Usmani - Joint Secretary of TBCFI informed the house about the election procedures which was started in the month of October 2019. Meeting was held on 3rd October 2019 during the Junior National at Nagpur and on 29th December 2019 at Gorakhpur GB Meeting of TBCFI, in both meetings of TBCFI the house has decided the next term election of TBCFI for 2020-2024 which will be held at Gorakhpur (U.P.) on 16th of February 2020 (minutes of both meetings attached herewith). - 3- Shri Jawaid Anwer, executive member told the house that there are few important issues which needs to be discussed and addressed for the betterment of the Federation and would be brought in the house in the next GB meeting. - 4- Shri Salim Khan, Secretary (Rajasthan) suggested that TBCFI should proceed to get affiliation from Indian Olympic Association (IOA) and All India University Games. Shri Tausif Ahmad (U.P.) told that proceeding to include the game in Indian Olympic Association (IOA) and All India University Game have been made in past. Shri Imran A. Lari Secretary General, said that Shri Deshraj Karnwal Vice President of TBCFI is an significant person and can do better in this matter. Shri Deshraj karnwal assured the house that he will do all efforts for the cause.

 - b) Junior National Tennis Ball Cricket Championship allotted to Rajasthan TBCA to host in the month of September last week 2020.
 - c) Senior National Tennis Ball Cricket Championship allotted to Telengana TBCA to host in the month of November last 2nd week 2020.

- Federation Cup Tennis Ball Cricket Championship allotted to Chhattisgarh TBCA to in the month of December 3rd week 2020.
- e) North Zone Tennis Ball Cricket Championship allotted to Chandigarh TBCA to host in the month of June 1st week 2020.
- f) West Zone Tennis Ball Cricket Championship allotted to Goa TBCA to host in the month of May 1st week 2020.
- g) South Zone Tennis Ball Cricket Championship allotted to A.P. TBCA to host in the month of September 1st week 2020.
- East Zone Tennis Ball Cricket Championship allotted to Nagaland TBCA to host in the month of May last week 2020.

The above mentioned events allotted by the house was unanimously passed and house has also decided if any State/Unit fails to conduct the above mentioned events can be allotted to another state/unit directly by the TBCFI President & Secretary General.

- 6- Shri Imran A. Lari Secretary General of TBCFI expressed his dissatisfaction on less participation of women/girls teams in National Championship. He appealed all state/units to make sure the participation of women/girls teams in all events.
- 7- House has also decided that state which fails to participate in the upcoming nationals for three consecutive nationals championships will be disaffiliated automatically and have no place for consideration in TBCFI. Federation has power to constitute an ad-hoc committee in that state/unit in large interest of the players of that state/unit.
- 8- House has given the power to President & Secretary General along with Shri Rajkumar Kaithwas, S.K. Panda & Amjad Usmani to form the sub-committee of TBCFI for 2020-2024.
- 9- It is also decided to review the constitution of Tennis Ball Cricket Federation of India (TBCFI) for any amendment if needed. In this regard Federation legal advisor Shri M.J. Akthar, Imran A.Lari, Secretary General & Shri Jawaid Anwer is authorized by the house to purpose the required amendment to the house.
- 10- It is also decided that it is mandatory for every state/unit to send one qualified umpire in the upcoming Senior National At Bareilly (U.P.) where a Umpire Clinic will be conducted.

Finally Dr. Gangadhariah thanked to all the elected office bearers for the term 2020-2024.
